## **Data Privacy Statement**

Since May 25<sup>th</sup> 2018, on the introduction of the General Data Protection Regulation, North Essex Astronomical Society (hereinafter known as "we" or "the society") has continued to protect the personally identifiable information (hereinafter known as "personal information") of its members (hereinafter known as "you") and only uses your personal information for the purposes set out in this statement.

#### 1. Consent

By applying for membership of the society or by renewing your existing membership of the society, you consent to us collecting, storing and processing your personal information as set out in this statement, including any future version of this statement of which we notify you.

If you do not consent or wish to withdraw previously provided consent, you may terminate your membership immediately and request that we erase your personal information as describe in section 3 below.

### 3. Your rights

#### You have the right:

- To receive a copy of the personal information that we hold about you;
- To request that we correct your personal information;
- To receive details of third parties that your information has been shared with;
- To request that we erase your personal information upon you ceasing to be a member of the society.

## 4. Storage, processing and retention of your personal information

We store your personal information on a cloud-based system which is only accessible to authorised members of the committee and third-party data processors as described below.

Your personal information is only shared with third party data processors under contract to the society for the purposes set out in section 1 above.

Your personal information is deleted from our records three months after your membership lapses, in order to give you a small window of opportunity to renew a lapsed membership.

The society's Data Protection Officer is the Chairperson as elected at each Annual General Meeting of the society.

### 6. Data Breaches and Complaints

Any alleged data breach will be investigated by the Data Protection Officer and the findings reported back to you as soon as reasonably practicable.
